- For the first time, BES is a K-8 school! Division 3 (Grade 7 & 8) students have had the opportunity to experience a number of different CTF courses; Entrepreneurship, Digital Media (and working on a Yearbook), Art, Music, French, Outdoor Education, Photography
- Teachers have been consistency working on improving their practice and formative assessment strategies to strengthen learning for all students. Professional learning occurs at the district and school levels, including professional learning Friday afternoons, Response to Intervention (RTI) Mon-Thurs mornings, and weekly common collaboration times
- Outdoor pursuits- thank-you to the many generous supporters. The BES Outdoor Pursuits provides affordable opportunities for all BES students to partake in a variety of outdoor activities (new this year was canoeing for Gr. 8)
- Nature Explorers this is the fifth year of full-time NE which supports a strong connection to the classroom, the curriculum and the Teacher Effectiveness Framework. A huge thank you to School Council for your ongoing support of this program!
- RFTS continues to play an integral role in our school
- Hot Lunch we love having parents so central in the front foyer serving lunch to very appreciative students and staff! Hot lunch will be moving to the hallway in front of the new kitchen next week.
- Gr. 5-7 running clubs, Soul Warmers, Drama, and numerous other clubs were offered throughout the year to keep students engaged over the lunch hour
- Quest Theatre was hired to provide an intensive, week- long drama residency for grades 2-8. This initiative was inspired by the feedback from student, parent and teacher surveys asking for drama opportunities
- Before School Care CRPS initiated and financially supports this program at BES to support families who were struggling with childcare before school. It is a free to all families and has grown to 40 students each morning
